Terms and Conditions

A first installment payment equal to one-third the package price is required in order to reserve Aly Hathcock Media's (AHM) services for the wedding date. A second installment equal to one-third the package price will be due 30 days prior to the wedding date. AHM will not begin videotaping until this payment is received. The final balance will be due upon completion of the video. If the client cancels the production prior to the wedding date, the deposit and second payment will be refunded to the client only if AHM can rebook the wedding date.

The client is solely responsible for securing permission from the site owner/operator (plus any additional clearance permits and permissions required) for use of the production site as well as authority for AHM to set up all necessary production equipment. It is understood that the quality of the production is dependent upon adequate lighting, camera/microphone positions and other conditions not under the control of HM. The client warrants that he/she has the legal rights to anything AHM will videotape, including photos, musical recordings, videotapes, or any other materials delivered to AHM for inclusion in the client's DVD.

In the event that more than one client wishes to book wedding services on the same day, preferences will go to the first client to pay the deposit. Rescheduled weddings will only be accommodated if the new date does not conflict with the current schedule of AHM.

AHM is not responsible for poor audio if the groom does not agree to wear a lapel microphone, dark or grainy video resulting from inadequate lighting or the refusal of the client to allow camera-top lighting at the reception, or electrical or mechanical malfunctions on location that are beyond our control.

The agreement of the service to perform is subject to proven detention by sudden illness, accidents, acts of God, or any other legitimate condition beyond the control of AHM. Every reasonable attempt will be made to secure a backup videographer in such an unlikely event.

AHM will establish an arrival time for the wedding date with the client prior to that date and remain on duty for the number of hours included in the package. Coverage hours included in the package are for the wedding date only and must be consecutive. This block of time includes set-up and tear-down of equipment, transportation between venues and meal breaks.

AHM reserves the right to discontinue videotaping in any situation (ex: rain, extreme temperatures, humidity, hazardous locations) that could put the safety of the videographer or equipment at risk.
